This transfer must be done at least 2-3 working days prior to the in-person submission of the application and proof of payment must be submitted with the application. Payments can also be made in cash at the Consulate counter.
- When depositing the amount into the Consulate's Bank account, applicants are required to include the following information in the "Payment Description/Verwendungszweck": Name of Applicant or Firm; Application Reference No. (if available); Service Applied For.
- The application will be processed promptly upon receipt of the Fee in the Consulate's Bank account.
- No Consular Service will be rendered if the Fee is deposited or transferred to any other Bank Accounts.

- It is recommended that payments for the Renunciation of Indian Citizenship, Visa, and OCI services be made in cash at the counter of Consulate.
